Excerpts from the Island County Fair Association By-Laws:

ARTICLE II. OBJECTIVES

The objectives are:

- Section 1. To organize, promote, conduct and carry on an educational, agricultural, commercial and industrial fair in Island County for the purpose of arousing interest, informing and entertaining the people.
- Section 2. To operate as a non-profit organization, in cooperation with Island County 4-H Clubs; FFA; agricultural associations and federations; homemakers; recreation, civic and service organizations; and other groups and individuals whose works and interest are dedicated to the improvement and development of Island County.
- Section 3. To carry on projects or activities incidental to and in furtherance of the above-mentioned purposes which in any manner aid and assist in the objectives of the Association as set forth; to acquire real and personal property in conjunction therewith; and to function as authorized by law.

ARTICLE IV. MEMBERSHIP

- Section 1. **Eligibility.** Membership shall be open to individuals eighteen (18) years or older interested in promoting the objectives stated in Article II, Sections 1, 2 and 3.
- Section 2. **Application.** Application for membership shall be made to the Fair Association Secretary at a regularly-scheduled meeting.
- Section 3. **Dues.** The annual dues shall be at an amount set from time to time by the Association membership, payable upon initial application and renewable in January each year. Membership not renewed by the March meeting shall be dropped from the membership roster.
- Section 5. **Duties.** Members are expected to support the activities of the Association by regular attendance at meetings and active participation on committees and during the fair.
- Section 8. Members are eligible to vote at the next regularly-scheduled meeting after the meeting at which they become members.
